

# Privacy Policy

## Introduction

Welcome to <https://iit-tutor.in/> (the "Website"). We are committed to protecting and respecting your privacy. The purpose of this Policy is to inform the users the type of personal or sensitive personal data or information collected, purpose of collection and usage of such information and disclosure of information and reasonable security practices and procedures adopted for storage and protection of information. Please read this Privacy Policy carefully prior to accessing the Website. By using our Website, you agree to the terms of this Privacy Policy and Sprix disclaims all the liabilities arising therefrom.

This Policy is made in compliance with the Information Technology (Reasonable security practices and procedures and sensitive personal data or information) Rules, 2011 & The Digital Personal Data Protection Act, 2023.

## Definitions

- **Personal information** means any information that relates to a natural person, which, either directly or indirectly, in combination with other information available or likely to be available with a body corporate, is capable of identifying such person;
- **Sensitive personal data or information** of a person means such personal information which consists of information relating to;— (i) password; (ii) financial information such as Bank account or credit card or debit card or other payment instrument details ; (iii) physical, physiological and mental health condition; (iv) sexual orientation; (v) medical records and history; (vi) Biometric information; (vii) any detail relating to the above clauses as provided to body corporate for providing service; and (viii) any of the information received under above clauses by body corporate for processing, stored or processed under lawful contract or otherwise:  
provided that, any information that is freely available or accessible in public domain or furnished under the Right to Information Act, 2005 or any other law for the time being in force shall not be regarded as sensitive personal data or information for the purposes of these rules;

Both Personal Information and Sensitive Personal Data or Information are hereinafter referred to as "Personal Information".

- **Child** means an individual who has not completed the age of eighteen years.

## Information We Collect

We may collect personal information from you when you register on our website, subscribe to our service, filling up any form, at the time of admission meeting. This information may include:

- Student Email ID

- Student school
- Student Birthday
- Address
- Parents Name
- Parents Mobile No.
- Parents Email ID
- Parents company

We also collect non-personal information when visiting our website which may include:

- IP address
- Browser type
- Operating system
- Referring/ exit pages,
- Date/ time stamps
- clickstream data

We shall be responsible for only those information which we have specifically requested. Sprix will not bear any liability for the information they have not requested. Therefore, we request you not to disclose any information which we have not requested.

Further, while providing information, you should ensure the following:

- Not to impersonate another person while providing personal information for a specified purpose;
- Not to suppress any material information while providing personal information for any document, unique identifier, proof of identity or proof of address issued by the State or any of its instrumentalities;
- To furnish only such information as is verifiably authentic, while exercising the right to correction or erasure

### **Sources from where the information is collected**

We primarily collect personal information directly from you. However, there may be occasions when we gather information internally.

By providing us with your personal information, you grant us permission to collect and verify related information from other sources, unless you explicitly instruct us otherwise. Your consent helps us ensure the accuracy and completeness of the information we hold.

### **How we use your information**

We use the information we collect for various purposes, including:

- To provide, operate, and maintain our Website;
- To improve, personalize, and expand our services w.r.t. to carrying out our legitimate tutoring school business, educational materials publishing business, and educational IT business
- To communicate with you, including customer service and support

- To send you updates, newsletters, and promotional materials (option to opt out by using unsubscribe link in the email)
- To comply with legal obligations
- For any other purpose required for providing services

### **Information Sharing and Disclosure**

We do not sell, or otherwise transfer your personal information to outside parties without your consent, except in the following circumstances:

- To trusted third parties who assist us in operating our Website and providing our services, provided they agree to keep your information confidential
- To comply with legal obligations, enforce our site policies, or protect our rights, property, or safety.

### **Retention of Information**

Generally, most of the information is deleted when you delete your account. However, we retain some information for as long as necessary to meet your requirements or as required or permitted by applicable laws and regulations. ### **Restriction on Child**
